Summary

This report recommends the two policies not updated at the 23rd May 2016, Bush Fire Advisory Committee (BFAC) meeting, which were requested to be dealt with at the 4th July 2016, BFAC Meeting, being Policy 16.2 "Banning of Cooking and Campfire Within the Shire of Harvey" and Policy 16.7 "Bush Fire – Roadside Burning" be adopted by Council.

Background

As part of the ongoing review of Council Policies the Bush Fires section of the Policy Manual has been substantially updated as it is required to be from time to time. The detail of the two remaining policies and the reasons for their recommended updating is explained below.

Comment

Policy 16.2 Banning of Cooking and Campfires within the Shire of Harvey:

The current policy is **Attachment 1** with the proposed new policy being **Attachment 2**.

The reasons for the proposal to update this policy are as follows:

- The current list of authorised places is out of date with some not being under Council jurisdiction. Additionally because a place is included on this list does not mean that it automatically is a place where open fires can be lit during the Restricted or Prohibited Burning period.
- There does not need to be a list of places in this policy at all. A place would be considered on its merit by way of an application.
- Without this policy in place the same outcome applies per Section 25 (1) of the Bush Fires Act 1954.
- The new Policy adopts the preferred Policy format.
- In the practical application of this Policy it is highly unlikely that any approval for an open fire would be given during the Prohibited Burning Period. As per paragraph 2 under the heading of "Objective" any approval given for an open fire during the Restricted Burning period is subject to the issue of a permit by the relevant Fire Control officer.
- Delegation 1.1.11 is in place relevant to this Policy.

Policy 16.7 Bush Fire - Roadside Burning:

The current policy is Attachment 3 with the proposed new policy being Attachment

The reasons for the proposal to update this policy are as follows:

- The current Policy has outdated terminology (Shire Engineer).
- The updated policy recognises that Road Reserves are the responsibility of the local government and the form of a "permit" would be an approval letter and have no reference to a Bushfire "permit" issued for burning under the Bush Fires Act 1954. The burning of Road verges would be primarily undertaken outside of the Restricted and Prohibited Burning period and would not be the subject of a normal Bushfire permit.
- The inclusion of an extra sentence in clause "d" which stipulates the Fire Control Officer for the area is to be advised before any burning is to occur.
- The new Policy adopts the preferred Policy format.

Statutory/Policy Environment

Bush Fires Act 1954.

The remaining two policies in the "Bush Fires" section of Council's Policy Manual are recommended to be updated.

Local Law Review - Bush Fires Subject:

Summary

Council is presently undertaking a statutory eight (8) year review of all of its Local Laws. The Bush Fire Brigades Local Law 2001 is one of these Local Laws and comments were sought from brigades prior to 17th June 2016, if there were any suggested changes.

Comment

The Uduc Brigade has sought a change to the Bush Fires Brigades Local Law primarily to streamline their financial processes and have them more in keeping with modern financial activity. Refer Attachment 5.

Essentially the brigade is seeking that the Local Law be altered to allow for electronic transfers in place of the current restrictive cheque only clause. This change if agreed to will only apply to funds that are held by brigades and not ESL payments which are dealt with through the Shire.

There appears no reason to object to this change and wording has been used from another local government which has already introduced a similar change.

The current wording is:

"7.4 Banking

The funds of the bush fire brigade are to be placed in a bank account (1) and are to be drawn on only by cheques signed jointly by any 2 of the Captain, Secretary or Treasurer.

(2) If the Secretary/Treasurer is a combined position, the Captain and Secretary/Treasurer are to sign the cheques referred to in subclause (1)."

The proposed wording would be changed to read similar to that below:

- "7.4 Banking
- (1) The brigade must have three (3) Committee Members to act as signatories for the brigade accounts each Financial Year.
- A minimum of two (2) signatures is required on any brigade account (2) cheque or bank transaction form."

The specific wording does not need to be confirmed at this point as this will occur when Council formally amends the Local Law. The current review identifies the intent and the recommendation to this report reflects this.

Statutory/Policy Environment

The Local Government Act 1995 Section 3.16 (2) sets out the Statutory Local Laws review process. The Bush Fires Act 1954 is a key reference point in the application of the Local Law. The Local Law relating to Bush Fire Brigades 2001 is the principal statutory document being reviewed.

Strategic Framework

Within the Shire's Strategic Community Plan 2013 – 2023, Strategy 4.2.2 states:

"Maintain, review and ensure relevance of Council's policies and local laws."

Risk Management

Subject: Community Emergency Services Coordinator

Appointment as Fire Control Officer

Summary

The Community Emergency Management Coordinator Mr. Michael (Mike) Carter commenced with the Shire in October 2015. This report recommends that Mr. Carter be appointed as a Fire Control Officer for the Shire of Harvey in accordance with the Memorandum of Understanding in place between DFES and the Shire of Harvey.

Background

This position is jointly funded by Council and the Department Fire and Emergency Services (DFES) and Mr. Carter is suitably trained to hold the position of a Fire Control Officer. At the 24th May 2016, Bush Fire Advisory Committee Meeting the following resolution was passed in relation to this matter-

"BFA-16/038. Papalia/Pryce

"That Mr. Ross Bradshaw, Department of Fire and Emergency Services, investigate further the requirement for Mr. Michael Carter to be appointed as a Fire Control Officer as part of his role as a Community Emergency Services Coordinator.""

The Committee wanted to ensure the separation of duties between the Community Emergency Services Coordinator and Fire Control Officers. This clarification was subsequently sought from the Department of Fire and Emergency Services and the following tasks have been specifically identified where the Community Emergency Services Coordinator would be required to perform functions that require a Fire Control Officer appointment –

- Enter a property post fire to investigate and determine fire cause or make recommendations on follow up actions.
- As an authorised person take control of a fire during the authorised period (as occurred with the Myalup fire in February).
- To enter land, pull down, cut or remove fences on Private Property, other land or building, to examine land being lit, firebreaks, hazards and causes of a fire.
- Ask person to extinguish fire lit unlawfully, or accidentally.

Comment

It is stressed that there is no intention to have the Community Emergency Services Coordinator undertake activities such as the issuing of permits to burn or any other functions that would be normally undertaken by area Fire Control Officers.

The Memorandum of Understanding (MOU) in place between DFES and the Shire of Harvey states that "The Shire will appoint the officer as a Fire Control Officer in accordance with Section 38 of the Bush Fires Act"

Statutory/Policy Environment

Bush Fires Act 1954, Section 38(1), states that a Local Government may from time to time appoint such persons as it thinks necessary to be its Bush Fire Control Officers.

Strategic Framework

Within the Shire's Strategic Community Plan 2013 – 2023, Strategy 4.3.4 states:

"Monitor and ensure compliance with regulatory for Local Government business."

Risk Management

The Risk Theme Profile identified as part of this report is Ineffective Employment **Practices** and the Consequences are Property and Environment. The Risk Rating for this matter is considered "Moderate" and the Likelihood "Unlikely" resulting in a LOW risk being present.

Budget Implication

Nil

Officer's Recommendation

That Council appoints Mr. Michael Carter as a Fire Control Officer for the Shire of Harvey.
