## 6. Agenda Items

### **Project Updates**

- Yarloop Workshops Inc. update
  - Decommissioned railway lines have been sourced from Collie for use in the landscaping plan at the workshops. There will be costs incurred to pay the Collie Rail Heritage Group for the purchase and transport costs, the rails will need to be stored somewhere until they are required.
  - The tender process for the workshops building works has recommenced and multiple builders attended the mandatory site visit as part of the process.

- Harvey Internment Camp and Gaol Cells Interpretive Signage Project
  - A consultant has been contracted to complete design and documentation.
  - The previous Internment Camp Shrine Committee are looking at re-forming a committee, the Shire has not been advised as yet.
  - Shire staff will invite a member of the previous committee to any future HAG meetings that involve any decision making at the Shrine.
- Brunswick Agricultural Society Stables timber storage (refer Attachment 2)
  - Staff to liaise with Mark Talbot about getting some of the timber stored at his farm for use in the Interpretation Signage project for Brunswick.
- Draft Place Records for Local Heritage Survey
  - Staff shared the Dropbox details for the Draft Place Records for the 2023 Local Heritage Survey review.
  - A table will be distributed to let Group members know what localities are due for completion and the date.
