**Dog owner notes and responsibilities**

- Registration periods run from 1 November to 31 October each year. Expiry dates are printed on your dog's registration tag.
- All dogs over the age of three months are required to be microchipped for the purpose of identification and registration. Failure to microchip your dog may incur a fine of \$200 (if a dangerous dog, \$400).
- Dogs must wear a collar with a current registration tag when in public places.
- Dogs are to be under control of a competent person and on a lead of sufficient strength when in a public place.
- Dogs are to be exercised off a leash in designated areas only, with the person in control carrying a lead to ensure the dog can be restrained if required.
- The registered owner must notify the Shire in writing if there is any change in ownership of the dog/s on this application. Please ensure your contact details are kept current with the Shire and the microchip registry with which your dog is listed.
