How are rates calculated?

Each property is issued a Gross Rental Value (GRV) or Unimproved Valve (UV) based on location and zoning. This valuation is provided to the Shire by Landgate's Valuer General Office.

- Gross Rental Valuation (GRV) your property's estimated yearly rental income.
- Unimproved Valuation (UV) your property's estimated sale value.

Each year, the Shire sets a minimum charge based on services provided. If the calculation of the GRV or UV by the rate in the dollar results in an amount less than the minimum charge, then the minimum charge will be raised.
