### Statement on changes at the BHRC

Bunbury Harvey Regional Council (BHRC) has advised the Shire that trucks presenting with **FOGO** product containing **unacceptable levels of contamination** will now be directed to **landfill** for disposal. This is in response to **high contamination** volumes that **exceed** the **decontamination capacity** at BHRC. Until further notice, the collection contractors will assess the load going into the truck, and if contamination levels are too high, the load will be taken to landfill. It is important that the community continues to **separate** their **general waste** and **recycling from FOGO** correctly to ensure as little contamination is present as possible. There will be **no change** to the **collection frequencies** and residents are asked to continue to use their **lime green FOGO bin for organic matter only** for their weekly collections. Everyone in the community plays an important role in reducing FOGO contamination, further information and tips can be found at the Shire's website or <https://www.wastesorted.wa.gov.au/fogo>. The Shire remains committed to the important role FOGO plays in diverting waste from

landfill and recognises that high contamination impacts BHRC's ability to process and produce a high-quality end product.
