1. BASIS OF IMPOUNDMENT

3. DISPOSAL WARNING – SECTION 3.45 & 3.47

If the goods are not collected within one (1) month after service of this Notice, or within one (1) month and seven (7) days if the Shire is unable, after reasonable efforts, to locate you and serve this Notice, the Shire may sell or otherwise dispose of the goods without further notice, in accordance with section 3.47(2a)–(2b).

Money received from any sale will first be applied to costs incurred by the Shire, and any surplus will be credited to the Shire's trust fund as required under section 3.47(4).
