The appointed Brigade representative is the member who has a vote at the BFAC Meetings.

The Brigade representative to the BFAC will be the Fire Control Officer (FCO) for that Brigade. If a Brigade is unable to nominate a FCO and one is appointed by the Shire from the existing FCO's, then by default the Brigade representative to the BFAC will be the Captain or the next highest ranked Officer.

The Brigade proxy to the BFAC is the Captain for each Brigade or next highest ranked Officer.

Brigades are requested to elect the representatives at their Annual General Meetings and advise the Shire prior to the next BFAC Meeting to be held Monday 18 May 2026.

Summary

The Shire's Firebreak Notice and Bush Fire Information brochure is to be reviewed annually.

Background

The Shire's Firebreak Notice requires landowners and occupiers to undertake fire prevention works in accordance with the requirements of the Notice to assist in preventing the outbreak, spread, or extension of bush fires.

Previous Firebreak Notices, including the 2025–2026 Shire of Harvey Firebreak Notice, have specified fire prevention requirements based on both land zoning and land size. In recent years, local governments have progressively moved away from referencing land zoning classifications and have instead focused on land size as the primary basis for determining fire prevention requirements.

The Shire of Harvey has recently adopted an updated Local Planning Scheme, which has resulted in changes to a number of zoning classifications, including the change of the "Special Residential" zone. The updated Scheme also renames several zones and reserves to align with the State Planning Framework and improve consistency across planning instruments.

The key changes between the previous and current zoning classifications are summarised below:

Previous Scheme	New Scheme
Residential Development	Urban Development
Special Residential	Residential (with an R-Code)
Special Rural	Rural Residential
General Farming	Rural
Intensive Farming	Priority Agriculture

Special Residential

Properties previously zoned "Special Residential" are now classified as "Residential" under the updated Local Planning Scheme and are subject to the Residential Design Codes (R-Codes).

The R-Codes are a State Planning Policy that establish development standards for residential land, including building setbacks, site coverage, and boundary clearances. Development requirements vary depending on the applicable density coding, which ranges from R2 to R80.

Firebreak Notice requirements vary across local governments, with some continuing to apply traditional land size thresholds, based on half-acre and one-acre lots (2,024m² and 4,048m²), while others have transitioned to land size categories aligned with the Residential Design Codes (R-Codes) and metric-based measurements, such as 5,000m².

Comment

In addressing the updated Local Planning Scheme changes and considering the R-Code setbacks, it was considered that the following changes to the 2026–2027 Shire of Harvey Firebreak Notice.

All land greater than 5,000 m²:

- A three (3) metre wide firebreak, with a four (4) metre vertical clearance, shall be constructed and maintained as close as practicable inside the property boundary, but no more than ten (10) metres from the boundary, around the entire perimeter of the property.
- A three (3) metre wide firebreak with a four (4) metre vertical clearance shall be constructed and maintained immediately surrounding all outbuildings, sheds, haystacks and groups of buildings situated on the land.
- A three (3) metre wide driveway with a four (4) metre vertical clearance shall be installed and maintained.

All land 5,000 m² or less:

- All flammable matter on the entire property (not including living trees, shrubs, plants and reticulated lawns under cultivation) shall be reduced and maintained to a height of less than five (5) centimetres.
- three (3) metre wide driveway with a four (4) metre vertical clearance shall be installed and maintained.

Key Changes Between the 2025–2026 and Proposed 2026–2027 Firebreak Notice

The proposed 2026–2027 Shire of Harvey Firebreak Notice introduces a simplified and more consistent approach by removing references to land zoning classifications and instead applying requirements based solely on land size.

Under the 2025–2026 Firebreak Notice, requirements differed depending on zoning categories such as “Residential”, “Special Residential”, and “Rural” land. The proposed 2026–2027 Notice replaces this with two clear land size categories: properties greater than 5,000m² and properties 5,000m² or less.

The key changes are summarised below:

- Removal of references to Residential, Special Residential, and Rural zoning classifications.
- Introduction of a uniform land size threshold of 5,000m².
- Increase in the minimum firebreak width for larger properties from 2 metres to 3 metres.

- Increase in the permitted distance of perimeter firebreaks from property boundaries from 6 metres to 10 metres.
- Introduction of a mandatory three (3) metre wide driveway clearance requirement with 4 metre vertical clearance for all properties.
- Retention of vegetation management requirements for smaller residential style lots, requiring flammable material to be maintained below 5 centimetres in height.

The proposed changes aim to improve consistency, simplify compliance requirements for landowners, and better align the Firebreak Notice with contemporary Local Government practices and the Shire's updated Local Planning Scheme.

Consultation

Consultation has been undertaken with key stakeholders, including the Chief Bush Fire Control Officer and Deputy Chief Bush Fire Control Officers. A key issue raised during consultation related to existing properties that may require additional vegetation clearing to accommodate the proposed increase in firebreak width from the historical two (2) metres to three (3) metres, particularly within the Leschenault area. Approximately 240 properties in Leschenault exceed 5,000m² and may be affected by the proposed change in firebreak width requirements.

It should be noted that variations to the Firebreak Notice requirements may be considered where compliance with the prescribed standards is impractical. In such cases, approval may be granted for alternative firebreak alignments or alternative fire hazard reduction measures where these are considered to adequately mitigate bush fire risk.

Given the significance of the proposed changes, a comprehensive public education and communication campaign will be required to ensure landowners are informed of the new requirements and their obligations under the revised Firebreak Notice.

2026–2027 Burning Periods:

- Restricted: 2 November 2026 – 14 December 2026 (midnight)
- Prohibited: 15 December 2026 to 14 March 2027 (midnight)
- Restricted: 15 March 2027 to 15 May 2027 (midnight).

A final draft will be circulated to all brigades before final print.

Statutory/Policy Environment

Section 33 of the *Bush Fires Act 1954* empowers local governments to require landowners or occupiers to establish and maintain firebreaks and undertake other fire prevention measures on their properties. This provision forms the legal basis for issuing annual Firebreak Notices, which outline the specific requirements to reduce bush fire risks within the Shire.

It was further advised that information relating to deliberately lit fires should be provided to the District Officer Wellington or Regional Duty Coordinator.

Where evidence is present at the scene, attendance by WA Police should be requested through COMCEN.

Mr. Vaughn Byrd commended the Department of Biodiversity, Conservation and Attractions for the provision of machinery and equipment when required during fire response operations.

6.5 Community Emergency Services Manager (CESM)

The Community Emergency Services Manager's Report is attached for your information (***Refer to Attachment No. 6.5.1).***

Mr. Nick Mellowship spoke on the importance of accurately completing and documenting Incident Reports.

Mr. Wayne Jackson queried the current status of the Bushfire Operational Plans (BOPs). It was advised that Mr. Nick Mellowship has been preparing the BOPs, which are currently under review by the Manager Waste and Safety Services prior to progressing to Governance.

BFAC members requested that the BOPs be presented to the Bush Fire Advisory Committee for review prior to being presented to Council.

Cr. John Bromham requested clarification regarding the process for endorsement and implementation of the BOPs.

Mr. Vaughn Byrd raised concerns regarding the historical implementation of minimum training standards and queried whether implementation of the BOPs would involve greater consultation with brigades.

Mr. Vaughn Byrd also requested that the Local Government Grants Scheme (LGGS) Budget be presented to the BFAC for comment.

6.6 Manager Waste and Community Safety

Nil.

Mr. Haydn Jones, Manager of Waste and Safety Services, is currently on Annual Leave.

6.7 Bush Fire Risk Mitigation Coordinator (BRMC)

The Bush Fire Risk Mitigation Coordinator's amended Report is attached to the Minutes. The amended Report includes the 2026/27 Treatment Program (***Refer to Attachment No. 6.7.1***).

Mr. Vaughn Byrd requested clarification regarding the process associated with the Capacity Assessment currently being undertaken by the Consultant. Ms. Kaitlin Southgate advised that the report would not be amended by the Shire.

Mr. Byrd queried whether funding was available through the Peel Harvey Biodiversity Group (PHBG). Ms. Kaitlin Southgate advised that funding associated with that group is generally directed toward environmental works.

Cr. John Bromham queried whether volunteers holding Fire Control Officer training qualifications could have greater involvement in controlled burns.

Mr. Ricky Southgate requested that brigades endorse a list of Burn Control Officers. Brigade representatives present agreed to this approach.

7 General Business

7.1 Suppression Activities - Volunteer Timeline

Mr. Vaughn Byrd raised concerns regarding the amount of time volunteers are remaining on the fireground following suppression activities, noting that once an area has been deemed safe, ongoing responsibility should revert to the landowner.

7.2 Welfare for Volunteers

Mr. Byrd also raised concerns regarding delays associated with arranging food through the Ranger call process during incidents and queried whether brigades could have direct contact access to Rangers for this purpose. Further discussion occurred regarding control over the distribution of food on the fireground.

7.3 Appreciation – Use of Yarloop Volunteer Bush Fire Brigade Facility

Mr. Ricky Southgate thanked the Shire for making the Yarloop Brigade facility available for recent training activities.

7.4 Youth Ward Program

Cr. John Bromham raised the potential implementation of a youth award program within the brigades.

7.5 Fuel and Burn Notification Cards

Mr. Nick Mellowship reminded brigades to utilise their allocated volunteer fuel card allowances and advised that volunteers should liaise with their respective Captains regarding usage.

Mr. Nick Mellowship also advised that planned burn notification cards have been actioned for creation.

7.6 Name Badges for BFAC Members

Cr. John Bromham requested that name badges be provided for all BFAC members.

The third incident was between Coalfields Highway and Livingston Heights in Roelands which put properties under threat. Each of these incidents were prolonged and required every brigade within the Shire to undertake rotating shifts which we all know can become difficult. It was a huge undertaking by everyone and I, along with the Shire staff, appreciate what you do. I especially want to thank Leschenault VBFB and Roelands Olive Hill VBFB for their diligence in carrying out patrols of the above incidents on a daily rotation for a period of up to four weeks.

Out of these three events, and many more smaller incidents, it has been enlightening to see senior members of brigades take on roles involved within the Incident Control structure. We have noted many brigade officers and members also stepping up at smaller incidents, becoming Incident Controllers and gaining confidence in doing the role. And of course, where would I be without the Fire Control Officers and Brigade Captains. The role we undertake is never taken for granted. We deal with many issues that come our way, some not very popular, but we move on and continue to strive to better ourselves as best we can. You do an important role and it has been a pleasure to be a part of this group.
