

BUILDING FEES (EFFECTIVE 1st JULY 2018)

The following fees are payable on lodgement of your building permit application.

Estimated value of works is defined as the contract price. If there is no contract then value must include all goods, labour, services necessary, fees payable, overheads to be met and profit margin. Or as otherwise determined by Permit Authority.
