Cat Owner Notes and Responsibilities

- Registration periods run from 1 November, to 31 October each year. Expiry dates are printed on your cat's registration tag.
- Cat must be registered by the time they reach six (6) months of age, with the local government where the cat ordinarily lives. Failure to register your cat may incur a fine of \$200.
- Registered cats are required to wear the local government issued registration tag when the cat is in a public place, unless it is exempt. Failure to wear a tag may incur a fine of \$200.
- Cats that have reached six (6) months of age are to be sterilised, unless exempt. Failure to sterilise your cat may incur a fine of \$200.
- If exempt from sterilization, a certificate given by the veterinarian must be provided.
- If exempt from being an approved breeder, please provide details.
- The registered owner must notify the Shire in writing if there is any change in ownership of the cat/s on this application. Please ensure your contact details are kept current with the Shire and the microchip registry with which your cat is listed.
